This policy applies to all business operations, manufacturing units, facilities, offices, and related activities of Adani Solar, including its subsidiaries and joint ventures, wherever applicable. This policy, under the Adani Solar brand, covers (Mundra Solar Energy Limited, Mundra Solar PV Limited & Adani New Industries Limited {I&W, Cell and Module}).

The commitment:

The organisation shall work consistently to ensure that the workplaces are not only welcoming for all genders, ethnicities, backgrounds, age, caste, religion, marital status, colour, state/ location, sexual orientation, language, and disabilities but that people are also treated with equality and respect.

Adani Group is continuously striving to be an equitable workplace promoting pay parity, skill balancing, inclusive culture and of diverse demography.

The Policy:

The Diversity, Equity and Inclusion (DEI) policy provides a strategic framework for monitoring and improving the organizational capabilities to improve representation and promote a more inclusive culture. All our businesses must demonstrate a commitment to the following principles:

- To comply with all applicable government regulations that seek to protect and promote diversity in professional activities
- To Promote Diversity, Equity and Inclusion in all its HR actions like recruitment, compensation, promotions, career growth, performance, etc.
- To inculcate the principles of Diversity, Equity and Inclusion in all its stakeholders such as Vendors, Partners, Contractors, etc.
- To support and empower differently abled individuals in the professional journey by providing accessibility support
- The policy encourages respectful communication and cooperation amongst all employees
- To provide adequate flexibility to accommodate employees' varying needs without any discrimination by the respective authorities in the organization
- To develop holistic training programs for new employees to accelerate their alignment with the organization culture, values, the company mission, and vision
- The organisation shall appoint a Review Committee which will monitor the necessary parameters to ensure that Diversity, Equality, and Inclusion (DEI) principles are being deployed in the right spirit. The review committee shall also make appropriate reports and presentation wherever required
- The organisation takes allegations of discrimination, harassment and bullying seriously and ensure they are appropriately investigated. To action these the organisation will appoint appropriate members to form the 'DEI Safeguard Forum'
- To set internal targets for strengthening Diversity, Equity and Inclusion, and to periodically review these targets to continually enhance diversity representation, workplace accessibility, and inclusive practices across the organisation.

Reporting inappropriate Conduct:

- If any employee believes that they or another individual has been treated unfairly or has been discriminated against on account of any of the parameters mentioned in this policy or its intent, the employee is urged to bring this to the notice of DEI Safeguard Forum
- All reported incidents will be investigated with an effort to keep the source of the report confidential, with the disclosure of information as appropriate to facilitate the investigation or resolution of the matter

- Adani Group encourages employees to report in good faith any possible violation of this Policy
- The organisation will not tolerate threats or acts of retaliation of any kind against any individuals because they report conduct reasonably believed to violate this policy or in good faith provide information in connection with a report or investigation of any such conduct
- Any employee found to have exhibited any inappropriate conduct or behaviour against others will be liable to disciplinary action
